Active parishioners of the Church who participate in the faith life of the parish by giving fully of their time, talent and treasure and by regularly attending Sunday Mass and Holy Days of Obligation are eligible for a discretionary tuition reduction. This reduction will be divided by child when reflected on your tuition billing statement. Additionally, parishioners with two or more children are eligible for a multi-child discount.

Annual tuition and fees will be managed by FACTS Tuition Management. SRL accepts the Step-Up, AAA and Family Empowerment-EO State Scholarships. All families are required to enroll with FACTS for tuition payments. Payments are made through automatic bank draft only. FACTS allows families the option to select a payment method that best suits the family's financial needs and are given the opportunity to pay the annual tuition in full or to make 11 (eleven) scheduled, monthly payments. FACTS online registration may be accessed through the school website or FACTS Management website www.factsmgt.com. Student registration for school is not considered complete until a payment plan has been established with FACTS.

Tuition will be billed 11 months, July through May on the 1st or the 15th of the month depending on which billing period is chosen when registering with FACTS. If paying tuition in full, the transaction will be debited in July. Tuition is past due if not paid by the contracted due date with FACTS. Children of parents who are "past due" will not be permitted to attend school until the account is brought current. Report cards, transcripts, visibility to gradebooks, and access to exams will not be released if there is an outstanding balance.

To prevent families from transferring out of a school without meeting their financial obligations, a child will not be matriculated into another Archdiocesan school when there is an outstanding debt in the last school attended. This policy also applies to students entering a Catholic high school.
